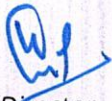


## **NO OBJECTION CERTIFICATE**

5. *It will be responsibility of the proposed school to obtain all necessary permissions from the Government of India and/or such Board for which this NOC is issued.*
6. *The proposed school shall adhere to all the provision of RTE Act, 2009 and RTE Rule, 2012 and shall appoint only qualified and eligible staff as per the qualification laid down by the concern Board.*

9. *According to the resolution dated 13/04/2018 of the Education Department, the Gujarati language education has to be implemented compulsorily.*
10. *The proposed school is bound and has to implement Resolutions/Circulars/Policies issued by the State Government/Education Department from time-to-time regarding school management, events, information and academic instruction.*
11. *Any point of time, if any of the document furnished by the Trust of the proposed school for the purpose of obtaining this NOC, found false or misleading or fraudulent, the issued NOC will be considered as cancelled.*
